**1. Quran recitation:** Br. Hassan Tahir opened the meeting with Quran recitation.

**2. IAMMP updates including State if MI inspection report and IRS nonprofit application:**

Br. Shakeel Pilot informed everyone that the State of MI inspection of our funeral home found a deficiency and we need to fix a curtain in the hallway to separate the funeral room from the hallway access. He will be working on this project during the weekend of 12/29/18. We will then send a picture of this curtain to the inspector, to establish compliance.

We will also have a lock box with key to the funeral room so that it is accessible to all BOD of IAMMP- Br. Shakeel Pilot or Br. Farooq Tahir will get a lock box and Br. Nazir will make a copy of the funeral room key for the lock box.

We have filed a response to the request for information from IRS regarding IAMMP nonprofit status. We will have to wait for a response from IRS at this time.

**3. Financial update:** Br. Safder Khan, treasurer was not present at this meeting. We have 12,784.00 dollars in the IAMMP account as of 12/28/18

**4. Review IAMMP bylaws and hold elections for IAMMP BOD:** Br. Farooq Tahir and Br. Shakeel Mirza were added to IAMMP BOD for a 3 year term (Jan 2019 to Dec 2021)

**5. Future plans for IAMMP:** Br. Farooq Tahir suggested that we reuse any non-soiled towels, he volunteered to help with laundering them.

Br. Shakeel Pilot noted that he has been in contact with the City of Brownstown with regards to converting part of the masjid land into cemetery. IAMMP BOD will assist in this process, by communicating with City of Brownstown. Br. Shakeel Pilot will conduct any necessary communication with IAM BOD.

We are also looking into options to reduce the cost of funeral, to be further discussed in subsequent BOD meetings.
